

Chinook Winds Canine Resort – Agreement & Waiver

By signing this document, I, the owner/agent/guardian, guarantee that I will be personally liable for all expenses resulting from daycare, boarding, veterinarian fees, property damage fees or any other expenses incurred while my dog is visiting or being boarded at Chinook Winds Canine Resort. I also understand that as the owner/agent/guardian I agree to indemnify and hold harmless Chinook Winds, its owners, agents and employees for any damaging acts to property or other animals while my pet is in transport or on the premise. Also, by signing this form, I authorize a Chinook Winds agent and/or employee to seek immediate veterinary care for my dog if deemed necessary by the agent and/or employee.

I understand that Chinook Winds Canine Resort is a cage free daycare facility (during allotted playtime). I accept all risks involved and agree that Chinook Winds is not liable for any injuries or illnesses during my dogs' attendance. I further understand that due to the way that the dogs interact with one another, minor cuts and scratches can occur even though the dogs are carefully supervised.

I understand and agree that in admitting my dog, Chinook Winds is relying on my representation and warranty that my dog is in good health and it has not harmed or shown aggressive behaviour towards a person or other animal. By signing this form, I certify that all information provided by me in my application form is complete and accurate.

I represent and warrant that my dog has not been ill with any communicable disease or otherwise in the last 90 days before his/her admission to Chinook Winds. I also represent and warrant that all required vaccinations are up to date and that my dog is receiving a monthly flea/worm treatment.

I hereby release Chinook Winds Canine Resort from all liability for any loss or expense that I may suffer or bare because of any happenings (including disappearance, runaway, sickness, injury, death from any cause, fire, theft, etc.) through transportation or otherwise during the time that my dog is in the custody and control of Chinook Winds Canine Resort. I understand that Chinook Winds Canine Resort will strive to provide the safest environment possible to avoid any such occurrences.

Although Chinook Winds Canine Resort carefully screens all applicants, the facility is occasionally discovered not to be an appropriate environment for every dog. Chinook Winds reserves the right to refuse service and permanently evict any dog at any time and for any reason without explanation.

I understand and will comply with the use of a leash or carrier when arriving at Chinook Winds Canine Resort, both on the property and inside the facility. I agree that my dog(s) will remain on leash or inside a carrier until care is passed over to a Chinook Winds staff member.

Furthermore, I understand to not approach any fenced in area without permission given by Chinook Winds staff.

All fees for boarding or daycare must be paid in full before any dog will be released from Chinook Winds Canine Resorts care. Failure to provide payment in full will result in further boarding and/or daycare charges to my account.

Chinook Winds Canine Resort offers a discount on additional dogs from the same household; however, this discount only applies if the guests can occupy one single kennel. If additional kennels require occupancy, the discount is void.

I understand that there are inherit risks to dogs being kennelled together, and I hereby release Chinook Winds Canine Resort from all liability for any loss or expense that I may suffer or bare because of any happenings due to my dogs being kennelled together during the time that my dog is in the custody and control of Chinook Winds Canine Resort. I understand that Chinook Winds Canine Resort will strive to provide the safest environment possible to avoid any such occurrences. I understand that kennelling dogs together is not always possible, and Chinook Winds Canine Resort reserves the right to kennel all dogs separately as deemed necessary.

I understand that if a period of ten (10) days has passed since scheduled pick up date without any contact from myself, emergency contact or the authorized pick up person, and payment has not been received, Chinook Winds Canine Resort reserves the right to surrender my dog to the local SPCA or rehome as seen fit.

At Chinook Winds Canine Resort, we offer peace of mind by allowing check ins via phone calls and emails. While your dog is boarding with us, we ask that family members or friends not stop by to visit during their stay as it is quite upsetting to the dogs' in our care. We assure you that if there are any issues concerning the well being of your pet, you will be notified immediately.

I certify that I have read and understand the terms as set forth herein and that I have read and understand this agreement. I agree to abide by all Chinook Winds Canine Resort policies and procedures and accept all the terms, conditions and statements of this agreement and confirm the truthfulness of the contents of the application form completed by me. I certify by signing this document that I am fully aware of all risks and that this document is considered legal and binding.

I have read and agree to all the regulations as listed in the Policies & Procedures document.
